Every task assign to GIDIFA for it's monetary needs, GTSST will handle them with effectiveness and proficiency subject to a Joint Taskforce Operation Treaty between Angel Ferdinand Marcos and Federal Fiduciary Deputy General Irving W. Jackson and GIDIFA, The Honorable AFM Marcos, Secretary General & Global Ambassador
- c. The Honorable Angel Ferdinand Marcos agrees GTSST's (CMPI Credit Processing System) will benefit Transapone Association + GLOBAL INFRASTRUCTURE DEVELOPMENT AND INTERNATIONAL FINANCE AGENCY related to GIDIFA. More importantly, in "Good Faith Deposit's" Mr. Angel Ferdinand Marcos agrees to retain GTST in the amount Twenty Million United States Dollars (\$20,000,000) for implementation of GTST's | CMPI Credit Processing System to go on line as describe in the invoice №: 002 | P.O. №: GTFI001. 1.2. Position. GTST shall engage the services of Mr. Angel Ferdinand Marco and grant the authorization of funds for the position of an authorized representative for GTST. As such, AUTHORIZED REPRESENTATIVE shall have the responsibilities, duties, and authority enumerated under GTST as well as those customarily pertaining to such position consistent with such GTST Organization and such other services as may be requested of AUTHORIZED REPRESENTATIVE by GTST.

### 1.3. Primary Duties and Services.

(i) GTST hereby appoints AUTHORIZED REPRESENTATIVE to be liaison or manager with respect to any and all dealings regarding FINANCIAL & BANKING relative to GTST or otherwise, regarding the management of the transaction identified by GTST (and others) and the transactions connected therewith in conjunction to the aforementioned agreements as stated therein. GTST does so for the purpose of providing for a day-by-day manager to be solely responsible for any and all activities of GTST with reference to the above transactions described herein and provided transfer documents.

(ii) AUTHORIZED REPRESENTATIVE agrees to serve in said position and to perform diligently and to the best of Mr. Angel Ferdinand Marcos AUTHORIZED REPRESENTATIVE's abilities said duties and services referred to in Section 1.2, and in such a manner as Mr. Angel Ferdinand Marcos AUTHORIZED REPRESENTATIVE deems advisable within the parameters as established and acceptable to GTST, as well as, such additional duties and services appropriate to such position which the parties mutually agree upon from time to time.

(iii) Mr. Angel Ferdinand Marcos AUTHORIZED REPRESENTATIVE shall have the ability and authority to perform such duties in accordance with AUTHORIZED REPRESENTATIVE's coordination with GTST & TRUSTEES.

(iv) Mr. Angel Ferdinand Marcos AUTHORIZED REPRESENTATIVE shall be solely responsible for obtaining and maintaining all appropriate information concerning the day-by-day, as well as business plans and future activities of GTST as it relates to GIDIFA.

1.4 Other Interests. During the period of time as set forth in this Agreement, Mr. Angel Ferdinand Marcos AUTHORIZED REPRESENTATIVE shall have full discretion to devote as much time and effort in performing his/her duties as AUTHORIZED REPRESENTATIVE deems necessary in order to carry out and maximize AUTHORIZED REPRESENTATIVE's performance hereunder. AUTHORIZED REPRESENTATIVE may engage, directly or indirectly, in other related businesses that do not conflict with AUTHORIZED REPRESENTATIVE's duties hereunder and/or the business of GTST. The foregoing limitations shall not prohibit AUTHORIZED REPRESENTATIVE from serving in other capacities for other organizations, or on GTSTs of other organizations, provided that AUTHORIZED REPRESENTATIVE's service in such other capacities for such other organizations and/or on such GTSTs is not adverse to the interest of GTST, Trustees.

1.5 Independent Status. AUTHORIZED REPRESENTATIVE shall be maintained as an independent contractor for purposes of taxation and liability. AUTHORIZED REPRESENTATIVE shall be solely responsible for any and all withholding of applicable tax, as well as, any and all contractor-related expenses based on the applicable law.

1.6 Primary Office Location. AUTHORIZED REPRESENTATIVE shall perform his or her duties at any location which he/she deems appropriate, but shall represent the address of GTST listed first above as the Primary Office Location for any and all accounts, transactions, and business of GTST, as well as for all expenses incurred by GTST, AUTHORIZED REPRESENTATIVE shall represent the address of GTST as his/her official Primary Office Location for all such purposes.

1.9 Business and Other Materials. AUTHORIZED REPRESENTATIVE shall be responsible for the distribution of all such materials representational of GTST's business and other interests. ## ARTICLE II TERM, DURATION, AND TERMINATION

2.1 Term. AUTHORIZED REPRESENTATIVE's contract is automatically terminated upon insubordination by AUTHORIZED REPRESENTATIVE, or by written notice for cause of the termination of this contract.

2.2 The parties' Right to Terminate. The provisions of this article are in no way intended to take away or otherwise waive any rights that GTST may have under the law. The parties shall have the right to terminate this Agreement at any time with sixty (60) days prior written notice for "Cause," which for the purposes of this Agreement shall mean (A) AUTHORIZED REPRESENTATIVE's dishonesty or fraud with respect to the reputation and/or affairs of GTST which materially and adversely affects the business and other relations of GTST, provided AUTHORIZED REPRESENTATIVE fails to cure such ill repute within a reasonable period of time; or (B) a material breach by AUTHORIZED REPRESENTATIVE or GTST of this Agreement or any other agreement by and between AUTHORIZED REPRESENTATIVE and GTST provided either party fails to cure such breach, if curable, within thirty (30) days of receipt of written notice thereof. Upon Termination of this contract for any reason the current or resigning AUTHORIZED REPRESENTATIVE can only be replaced by the first in line Successor AUTHORIZED Global Treasury Supreme GTST an International Irrevocable Express GTST Organization REPRESENTATIVE This shall in no way affect or preclude the consummation of any transaction, which was effected prior to such termination.
