## **TREATY AND JOINT FORCES AGREEMENT**

This Treaty and Joint Forces Agreement, hereinafter referred to as the **"Treaty and Agreement,"** is concluded and ratified this 7<sup>th</sup> day of October 2016 in Angeles City by and between:

The Global Infrastructure, Development and International Finance Agency (GIDIFA), represented herein by its Honorable Secretary General, Angel Ferdinand Marcos, hereinafter referred to as the **"GIDIFA"**; and

The Tribal Government of the Philippines, represented herein by its Honorable Governor General Higyawan Na Holag-Ayan (Carmelito S. Escudero), hereinafter referred to as the **"TGP"**.

### **WITNESSETH; That:**

**WHEREAS,** GIDIFA firmly believes that it is possible to live in a world filled with abundance wealth, peace, and prosperity for all the people of the world due to the existence of a sufficient amount of wealth bestowed upon all humans in the world to guarantee their equitable living. Hence, GIDIFA is committed and determined to improve the quality of life and to insure the social and economic freedom of all people in the world, including tribal people in every country;

**WHEREAS,** pursuant to the United Nations Declaration on the Rights of the Indigenous People, the existing 110 tribes in the Philippines comprising an estimate of 14 million people has established and declared their own sovereign government which is the TGP in order to further their rights under Republic Act No. 8371, otherwise known as the **"Indigenous Peoples' Rights Act of 1997"**;

**WHEREAS,** GIDIFA and TGP recognize each other's sovereignty.

**NOW, THEREFORE,** GIDIFA and TGP conclude and ratify this Treaty and Agreement as follows:

1. GIDIFA shall grant to TGP the funds necessary for the infrastructure development of the 110 tribes of the latter;
2. GIDIFA shall assign an IBOE in the amount of Ten Billion US Dollars (US \$10,000,000,000.00) as an Initial Development Fund for the funding of Humanitarian Causes, Projects and Programs, of, by and/or for TGP;

3. GIDIFA shall support the provision of the following facilities/systems to TGP:

- a. Bullion bank;
- b. TGP government center;
- c. Tribal judiciary system;
- d. Security system;
- e. Health system;
- f. Economic Development; and
- g. Other social welfare facilities and systems.

4. TGP shall fully support the vision and mission of the GIDIFA.

5. GIDIFA and TGP shall jointly formulate the implementing rules and regulations of this Treaty and Agreement.
